Competition regulations:

1. Only SOS electronic customers who agree with below terms and conditions (hereinafter referred to as „a competitor“) unless further stated otherwise can participate in a competition.
2. Competition can be attended by any natural person, which agrees with the above mentioned conditions of the competition (hereinafter referred to as „participant of the competition“), unless otherwise specified. During the competition, the operator will publish competition question at [www.soselectronic.com/football](http://www.soselectronic.com/football) where all the participants can send their answers and play to win prizes.
3. Person employed by the operator of the competition or those who are in a similar relation with the operator cannot participate in competition. If it is proved that the winner of the competition is the above mentioned person, this person is not entitled to win the competition and the operator of the competition is enabled to deal with the prize in his/her own discretion.
4. Participants of the competition have the possibility to win some of the prizes if they from 1.6.2016 to 15.7.2016:
  - correct and timely answer for the competition question via filling out the competition form at operator's website while the operator will always publish the due date for sending out responses and thus play to win a prize that was chosen by operator.
  - send the correct answer together with the information based on which it will be possible to identify, contact and send the prize for them.
  - do not violate the competition regulations
5. Every participant of the competition who has met the conditions referred to in point 3 and whose answer for the competition question was correct and sent correctly and on time, will automatically be included in the draw for the prize announced by the operator in advance.
6. The winner randomly drawn by electronic means will be contacted by the operator based on contact details they provided within 4 business days once the competition is over. By participating in the competition, the winner agrees to publish their name and surname, eventually name of company and country at the operator's website in a list of winners of given competition.
7. In case of failure to comply with the conditions regarding receiving the prize determined by the operator, a person loses entitlement to win. In such case, the operator of the competition reserves the right not to repeat drawing another winner and the operator can deal with the prize in his/her own discretion.



8. If the winner refuses the prize from any reason or the operator cannot reach the winner within 5 days after the end of the competition round or the winner loses entitlement to win because of any failure to comply with the competition regulations or the law in connection with the participation in the competition, s/he loses the entitlement to win. In such case, the operator of the competition reserves the right not to repeat drawing another winner and the operator can deal with the prize in his/her own discretion.

9. Operator sends the prize based on their own discretion either using courier or it will be sent to postal address of the winner.

10. The winner cannot assign the right to the third party. In case the winner did not comply with or violated some of the rules of these competition regulations, the operator has the right not to provide the winner with the prize.

11. Prizes are not subject of legal right and one cannot prosecute a claim of this kind. Prize with the value exceeding 350,00 EUR is subject to the tax according to the relevant provisions of Act No 595/2003 Coll. on income tax as amended (§ 8, sec. 1 i) and § 9, sec. 2 m)). The value of the prize is to be noted in your tax return. When providing non-monetary prize, operator of the competition is obliged to inform the winner about the value of the prize, which is the acquisition value or operator's or provider's costs.

12. During the competition, the operator reserves the right to amend and to adjust competition regulations. Any changes in the competition regulations will be published at [www.soselectronic.com/football](http://www.soselectronic.com/football).

13. In case of conflict between the provisions of competition regulations and information provided in promotion materials relating competition, especially from a banner ad placed at operator's website, provisions of these competition regulations always take precedence.

14. Operator of the competition protects personal data of competition participants during competition according to law. By participating in the competition participants agree and declare that with the reference to the Act No 428/2002 on the protection of personal data, they provided data of their own person (especially referring to name, surname, address and email and telephone contact) and they provide these data to the operator of the competition voluntarily, for an indefinite duration of validity of this agreement which can be revoked at any time by letter sent to the address of the company operator listed at the beginning of the competition regulations. Personal data are provided solely for the purpose of competition participants' record and for the purpose of sending the prize to winner of the relevant competition round and will not be provided to any third party.

15. Provisions of this competition regulations, operation, process, competition and evaluation of the results of the competition are governed by the legislation of Slovak republic.

16. Participants of the competition express unconditional consent to be bound by the competition regulations.
